### **SLED HELPS RESCUE 33 DOGS, CHARGES TWO HORRY COUNTY RESIDENTS IN DOGFIGHTING INVESTIGATION**

The South Carolina Law Enforcement Division (SLED) charged Prentice Shiobhan Jackson, 47, with 33 counts of Ill Treatment of Animals, 16 counts of Animal Fighting or Baiting, and Criminal Conspiracy on Wednesday, April 15, 2026.

SLED also charged Rontisha Elena Huggins-Jackson, 48, with Criminal Conspiracy on Wednesday, April 15, 2026.

Details can be found in the attached warrants.

Both Jackson and Huggins-Jackson were booked into the J. Reuben Long Detention Center in Horry County.

The case will be prosecuted by the 15<sup>th</sup> Circuit Solicitor's Office.

SLED was assisted by the Horry County Police Department and animal rescue partners.

Between the dates of 01/27/26 and 03/18/26 Defendant, Prentice JACKSON, knowingly committed Ill Treatment of Animals, torture   
at his residence, Conway, Horry County, SC in that he did subject a tan dog (Dog 1) to unnecessary pain &   
suffering through inadequate shelter, lack of enrichment, & constant chain tethering. SLED surveilled the location between these   
dates showing a barrel "house" provided to Dog 1, had been moved within the living area, but no attempts to bring the housing to   
standards to prevent suffering were apparent. Instead, concrete blocks were added within the dirt circle, increasing chain movement   
difficulty & further limiting Dog 1's ability to move freely. JACKSON was determined to own the property & operate the "Pnitty's   
kennels" venture at the location, thus would have had knowledge of Dog 1's presence & suffering, & by acts of commission or   
omission, failed to provide Dog 1 with adequate care, violating S.C. Code of Laws, 47-1-0040(B).

bull-type dog (Dog 33). The scene, as well as Dog 33 were evaluated by a veterinarian, leading to the determination that Dog 33 had
been kept in a manner consistent with dogfighting operations, and exhibited scarring consistent with dogfighting injuries. Through a
large amount of physical & digital records seized by SLED, it was determined that JACKSON owned Dog 33 for no reason other
than fighting or baiting, to include breeding to perpetuate dogfighting, thus violating S.C. Code of Laws, 16-27-0030.
